**INSTRUCTIONS REGARDING FILL – IN ONLINE POST PUBLICATION REVIEW FORM IN M.Sc.  
Semester-III EXAMINATION – 2016 in Computer Science.**

1. (a) A candidate may apply for Post Publication Review of his/her answer-scripts in a maximum number of 50% of theoretical papers appeared in each semester examination in the prescribed Online Form. But he/she must have **to secure a minimum aggregate of 35% of the total marks in theoretical part of the particular semester (for Computer Science).**
  - (b) This is in connection with the Post Publication Review of Theoretical Papers of the candidates who appears at three / two /one paper(s) in any part of his / her examination availing his/her 2<sup>nd</sup>/3<sup>rd</sup> chance under Distance mode.
  - (c) It may be proposed that a candidate who appears at three / two /one paper(s) in any part of his/her examination under Distance mode availing his/her 2<sup>nd</sup>/ 3<sup>rd</sup> chance may apply for Post Publication Review of maximum two/one/one paper(s) respectively irrespective of marks obtained by the candidate in those / that paper(s), provided he/she has secured at least 30% marks in aggregate (in Whitten part only) of the remaining theoretical paper(s) not asked for Post Publication Review. The candidate who appears only single paper in any part of his/her examination availing 2<sup>nd</sup>/3<sup>rd</sup> chance, may apply for Post Publication Review for that paper only irrespective of marks obtain by him/her in that paper (**Written part only**).
2. Candidates are directed to read the instructions carefully before the Form Fill-up. After read and understand the instructions, filled in the required fields properly and submit it.
- A. After filling the required fields in the Online Post Publication Review form, system will generate a bank challan for online Post Publication Review and then students have to deposit the requisite fees as mentioned in the challan to a nearest branch of **State Bank of India**. Then candidates have to log on to his/her online Post Publication Review form once again (**within Two days of submission of Post Publication Review Form**) to insert the Journal No., Branch Code, Branch Name and Date of Deposition given by the bank on the Challan. The online Post Publication Review form will be treated incomplete without insertion of the Journal No. given by the bank after making payment of the requisite fees. **The requisite fees for Post Publication Review are as follows :** PTO
  - B. ₹ 150 for each paper or each Half.**
  - C. ₹ 100.00 as late fee.**

3. After verification of the payments details by our office (Minimum 2 days required for verification of the bank payment details from the date of payment details inputted by the Students) the candidates are directed to re-login the system and have to take print out of the said application form.

4. Candidates are directed to visit the **DDE Administrative Office / Study Centres** with the **Application Form** along with the following documents:

- A. **Original Bank Challan (University Copy).**
- B. **Photocopy of Enrolment Card.**
- C. **Original & Photocopy of B.U. Registration Certificate.**
- D. **Photocopy of Mark sheet.**
