INSTRUCTIONS TO FILL – IN ONLINE POST PUBLICATION REVIEW FORM IN MBA

SEM-IV EXAMINATION-2017 (Session: Jan, 2016 to Dec, 2017)

- (a) A candidate may apply for Post Publication Review of his/her answer-scripts in a
 maximum number of 50% of theoretical papers appeared in each semester
 examination in the prescribed Online Form. But he/she must have to secure a
 minimum aggregate of 35% of the total marks in theoretical part of the particular
 semester.
 - (b) There is no scope of Post Publication Review of Practical Paper(s) / Term Paper(s) / Project Paper(s) / Internal Assessment / Viva-Voce/ Grand Viva / Field Report / Survey Report, if any.
- 2. Candidates must fill in the form carefully before submission.
- A. After filling in the required fields in the Online Post Publication Review form Students are advised to complete the payment through online. Dashboard for students shows payment options i.e. 'Pay online'. After clicking 'Pay online' the student will get the following options: (i) Debit Card, (ii) Credit Card, (iii) Net Banking, (iv) NEFT / RTGS, (v) Cash Challan.
 - Any one option from above is to be chosen for making payment.
- B. Candidates are to take a print-out of the (i) Online Payment Receipt (by Debit Card/Credit Card/Net Banking) for online deposit or (ii) print-out of successful NEFT Challan or (iii) print-out of Bank Challan after depositing the requisite fees as mentioned in the Challan by cash to any branch of Allahabad Bank.
- C. If the original copy of the mark sheet does not reach by post till the time of filling the PP Review form, then paper wise mark statement can be seen while filling the PP Review form through student login.
- 3. The requisite fees for Post Publication Review are as follows:
 - ₹ 150 for each paper.
 - ₹ 100 as late fee.
