Extracts from the minutes of the meeting of The Court held on 19.01.2021


The Court considered the recommendation of the Executive Council made in its meeting held on 19.01.2021 regarding compliance of the points as raised by the UGC-DCB in its recommendation (received by the Registrar via email on 15th January, 2021) relating to the Application of University of Burdwan, West Bengal for recognition of ODL Programmes for 2020-21 – Communication of deficiencies/defects in the application for offering ODL Programmes and resolved as follows:


- i) The Court approved the rename of ‘The Directorate of Distance Education’ as ‘‘ Centre for Distance and Online Education (CDOE)’’ as per UGC Notification dated 4th September, 2020.
- ii) The Court resolved that Higher Education Department, Govt. of West Bengal be moved for creation of the following posts purely on temporary and contractual basis under Directorate of Distance Education, BU without financial liability on the part of the State Government. All financial liabilities would be borne by the DDE, BU and all other service condition would be governed by the DDE.
 - a) One post of Deputy Registrar (Purely Temporary & Contractual basis)
 - b) Two Assistant Professor (Purely Temporary & Contractual basis) M.A./M.Sc. in Mathematics
 - c) Two Assistant Professor (Purely Temporary & Contractual basis) M.Sc. in Computer Science
 - d) Two Assistant Professor (Purely Temporary & Contractual basis) M.A. in English
 - e) Two Assistant Professor (Purely Temporary & Contractual basis) M.A. in Bengali
 - f) Two Assistant Professor (Purely Temporary & Contractual basis) M.A. in Sanskrit
 - g) Two Assistant Professor (Purely Temporary & Contractual basis) M.A. in Philosophy
