The Vice-Chancellor, B.U. presided over the meeting and introduced the subject-matter of the meeting i.e., to take up effective steps in writing SIMs in History (new mode) and lessons in the old mode for Part II.

1. All teachers agreed to write study materials in the new mode as well as the old mode.
2. Regarding the lessons in the old mode for Paper II, it was resolved that despite the changes in syllabus, existing materials should be utilized as far as possible. 4. 5. Regarding the writing up of SIMs (in the new mode) the Faculty urged upon holding a Workshop sometime in December 2004 with participation of expert(s) from IGNOU, New Delhi and the prospective resource persons who will write SIMs.
